- **January 2010 Treasury Report – submitted by John Garrett**
 - **Current balance savings \$6005.00**
 - **Current balance savings \$456.30**
 - **Paid USCF insurance fee**
 - **\$300.00 negative Track balance not settled**
- **Thursday Crit Series – 2010**
 - **Andy Cummings instructed the following**
 - **In contact with both Buffalo City Officials and Pearl St. Grill proprietor and have been given a verbal contract.**
 - **Portion of the schedule will be USCF sanctioned**
 - **Possible corporate sponsorship at corners**
 - **Barriers are a concern**
 - **Marshalls needed but a local running club willing to lend a hand**
 - **Deadline in two weeks, permits from the City are the key.**
 - **Frank Grillo offering a backup course if this location does not work out.**
- **Hamburg Race Weekend – 2010**
 - **Proposed date of June 12-13**
 - **No commitment from local officials for money leaving a \$1500.00 gap**
 - **There is however commitment from Local Association**
 - **Considered switching crit to Saturday but reminded of road conflict to having the crit on Saturday, considering a RR rather than a TT on Saturday.**
 - **Committee will be comprised of; Stuart Green (Chairman), Terry and Lusinda Giswold, Ken Thomas, Duane W., & Pat Merrick**
- **ESG – Qualifiers**
 - **Peter Cummings reported that the ESG qualifiers will take place May 30th on the 2007 course but a bit of a smaller circuit.**
 - **Club should proceed with preparing for qualifiers as if the games are to happen.**
- **Changes to Race Categories**
 - **Motion was put forward to go with the USCF model and passed by a large margin of those voting.**
 - **BBC club races will now adopt the USCF model. There will be a Cat 1,2 & 3 race, a Cat 4 race and a Cat 5 race. There will no longer be A or B designations. Juniors racers TBD**
 - **What is printed on your license is the division that you will ride.**

- **Using this model will allow many of our club races to now be USCF sanctioned. This will mean that these sanctioned races will earn club members upgrade points for their license.**
- **Because of this new model team fees are TBD**
- **Race Schedule & Misc.**
 - **To include a possible 11 USCF races because of this there is a need for licensed officials. Members are encouraged to take the test to become so.**
 - **Fees for the USCF races are TBD**
 - **Chip timing discussed and encouraged but TBD mainly due to the cost involved and the ways to handle this expenditure. This may affect membership dues TBD.**
 - **Both the scheduled May 2nd and September 9th races have been switched to Saturday to accommodate both MTB and Cross races.**
